

AN AMHERST INVENTION

The James River Bateau was a river boat developed by Benjamin and Anthony Rucker of Amherst in the early 1770's. The bateau was used to transport tobacco from the western reaches of the Virginia Colony to the Tidewater. It replaced the Rose Canoe (Fig. 1), an earlier frontier boat made of two Indian dugouts strapped together.

In May of 1771 there was an immense flood on the James River that ruined the river towns all through Central Virginia. Many of the double-dugout canoes were destroyed, and during the rebuilding process the Ruckers introduced their bateau.

Thomas Jefferson had apparently never seen a craft like this before. In his notes from April 29, 1775 he describes the "Rucker's Battoe" as being fifty feet long, four feet wide at the bottom and six feet wide at the top. It would only draw thirteen inches of water when fully loaded with 11 hogheads of tobacco.

In order to secure the rights to the Bateau, the Ruckers were eventually convinced to acquire a patent for it. In 1821, approximately 50 years after the





Bateau was first launched, the patent was granted to the descendants of Benjamin and Anthony Rucker since both had died by that time. In this 50-year interlude, the idea had arisen that the Bateau was a common craft which had developed without an inventor. Some claimed that the family of the Ruckers was misusing the patent system and that no two people were responsible for creating the bateau. When the debate became public, Thomas Jefferson, who saw the first launching, was willing to testify on behalf of the Ruckers' claim to the patent. With Jefferson as the authority for the debate the issue was settled in favor of the Ruckers.

The bateau continued to be an influence on the James for many years after the patent was granted. Even after the long-awaited James River Canal reached Amherst County and larger packet boats began to be towed up the river, this unique craft continued to be used throughout Virginia. It was not until the Railroad replaced river transportation that the James River Bateau became obsolete and forgotten by later generations.

Now, nearly one hundred years after the Bateaux vanished from the James River and its tributaries, they have made a comeback. The bateau Columbia, taken down the James River in 1984, was the first reproduction to make the trip to Richmond. The new Spirit of Amherst bateau built in Amherst County is now complete. It is 50 feet long and 8 feet wide, and will be launched and christened on April 19, 1986. It will be entered in the James Cup Race from Lynchburg to Richmond on May 31, and later will be exhibited near the County museum. This replica is a physical link with the important era of the plantation economy, tobacco trade and river transportation in Amherst County.
